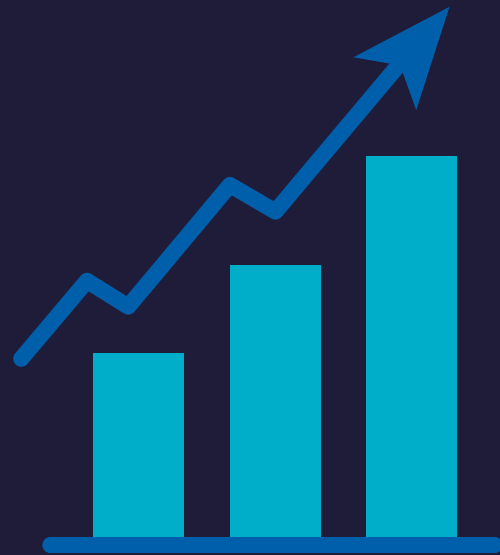

What in your view are Ireland's main competitive advantages that have caused your company to invest and expand here?

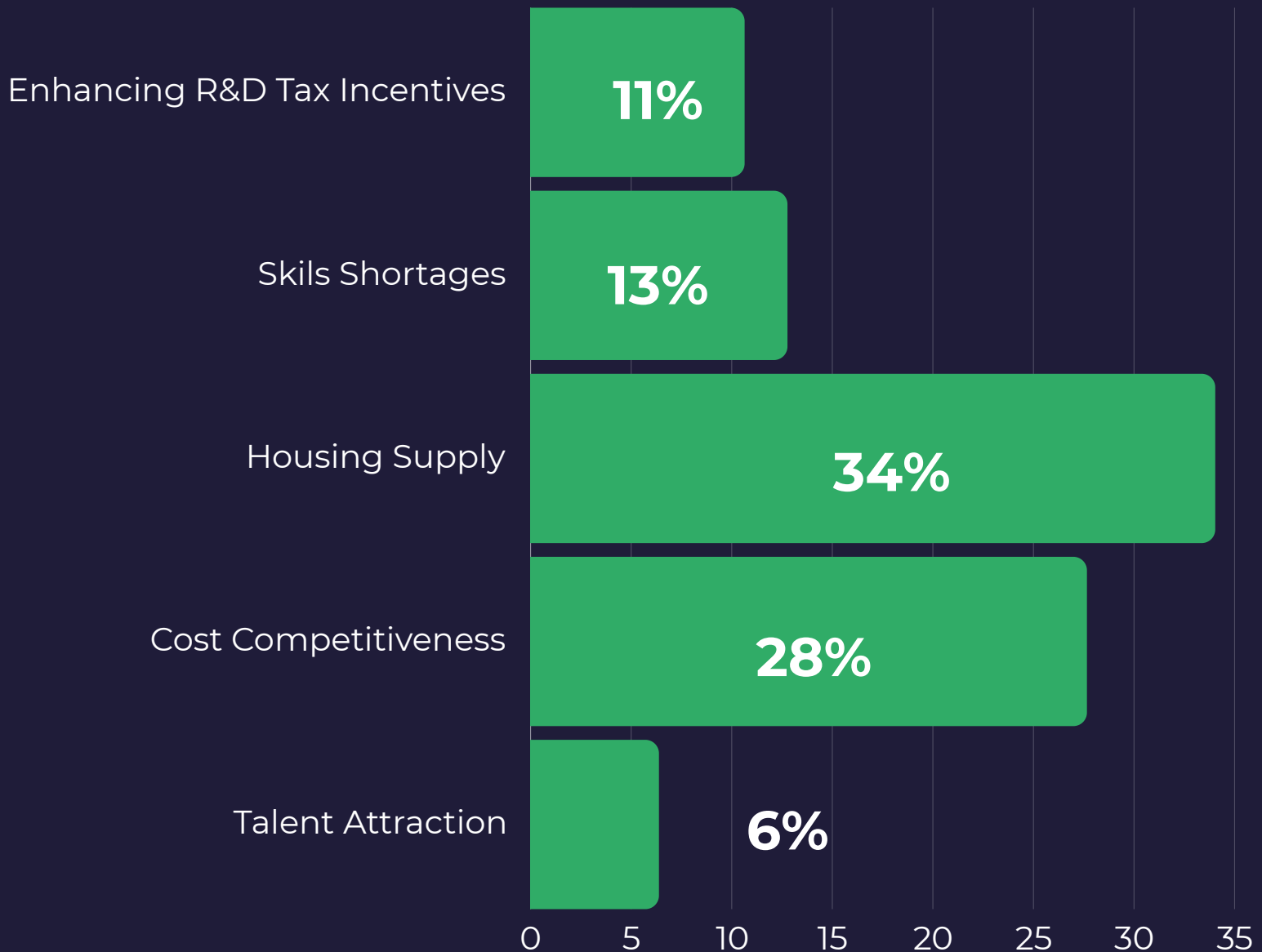

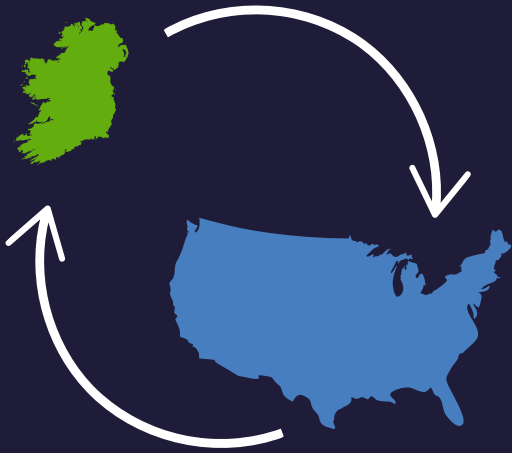
What is the number one challenge for Ireland to overcome for your organisation to expand here?

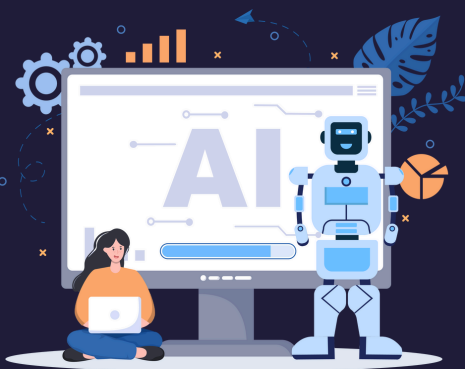

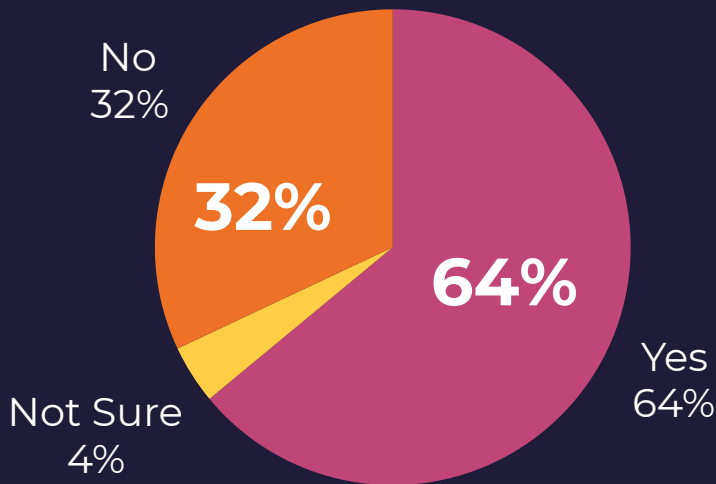

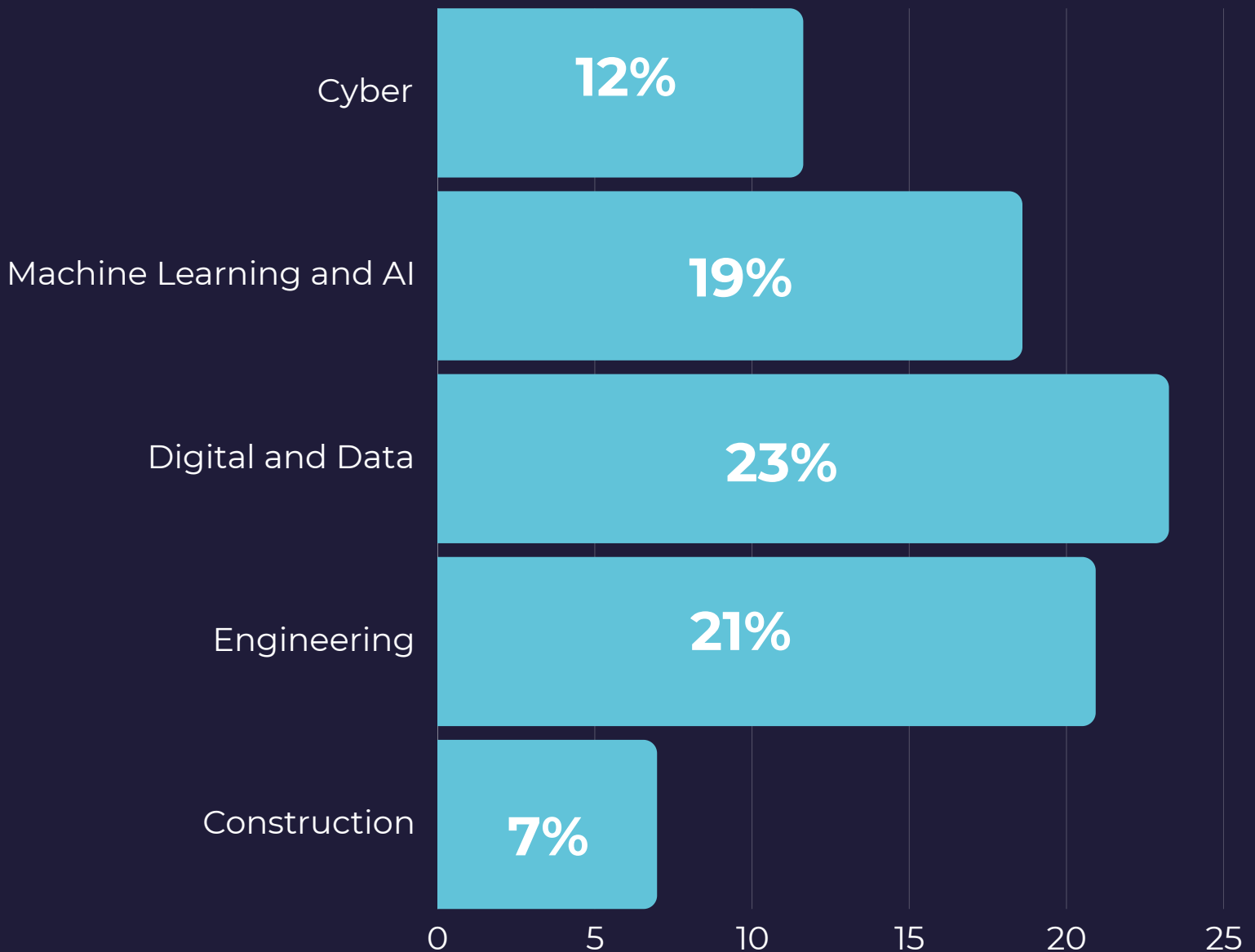

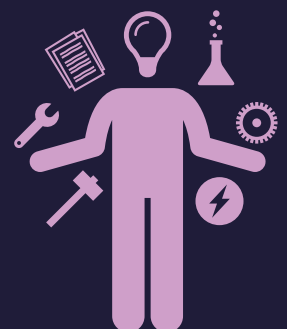

In what area, if any, is your organisation currently experiencing the greatest skills gap?



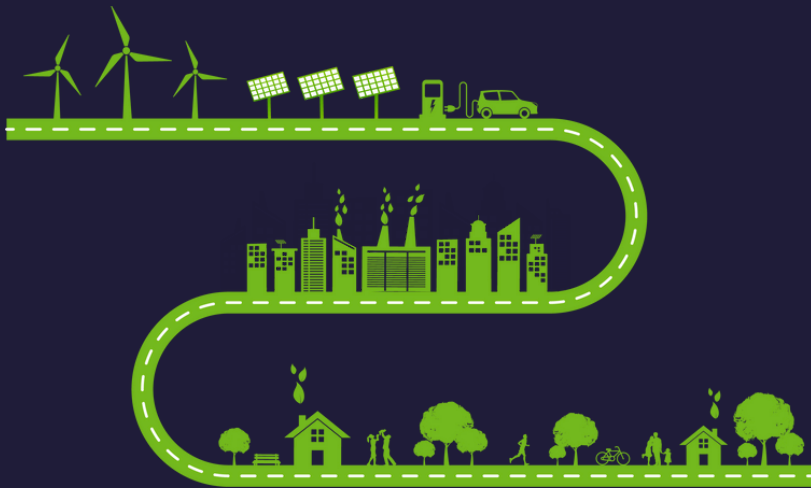
